#### Protective gloves

Suitable chemical resistant protective gloves (EN374) also at prolonged, direct contact (recommended protection index 6, corresponding 480 minutes permeation time according to EN 374) e.g. from nitrile gloves (0,33-0,5 mm) Polyvinyl Chloride (1mm).

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.

Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation

· Material of gloves

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.
